The memorandum of understanding is made entered into the 2nd day of April 2018.

BETWEEN

PRIYADARSHINI DENTAL COLLEGE AND HOSPITAL, No.1, VGR gardens, VGR nagar, Pandur, Tiruvallur – 631203, is a constituent of Indira group of educational institutions. Priyadarshini Dental College and Hospital is an institution evolved since 2007, recognized by Dental Council of India and affiliated to The Tamil nadu Dr MGR Medical University, with adequate infrastructure, equipments, lab and experienced faculties of an enviable track record to impart UG and PG program in Dentistry, is hereafter called the **PDCH**.

FOCUS CAREER ACADEMY, hereinafter referred to as **FCA** is an established academy providing specialized coaching for competitive exams like NEET, AIIMS, and All India Postgraduate Exams.

The parties wish to collaborate to provide training to students of Priyadarshini Dental College and Hospital for the above mentioned competitive exams.

RECITALS

Whereas the **PDCH** and **FCA** are willing to work together to offer joint program, including, but not limited to education, exchange of faculties, and also students' observation ship program, and have agreed to offer such program on the terms and conditions contained herein below.

NOW, THEREFORE for and in consideration of their mutual promises and understanding, both the parties agreed as follows:

TERMS OF UNDERSTANDING

Objective of collaboration:

This Memorandum of Understanding (MOU) outlines the collaborative efforts between **PDCH** and **FCA** for the purpose of providing a controlled environment to conduct specialized coaching programs for students of PDCH to prepare them for NEET, AIIMS, and All India Postgraduate Exams.

Venue:

The training programs will be conducted both inside the PDCH campus and at the premises of FCA during weekends.

Duration:

Both PDCH and FCA agree that the collaboration will be effective for an initial period of three years, with the possibility of extension upon mutual agreement subject to such terms and conditions as the parties shall determine.

Fees:

The fees for the training programs will be mutually agreed upon and communicated in writing. Any changes to the fees structure must be agreed upon in writing by both **PDCH** and **FCA**.

Student enrolment:

PDCH agrees to facilitate the enrolment process of interested students into the training programs conducted by FCA. The selection criteria for students will be jointly established by both parties.

Resources:

PDCH will provide necessary infrastructure and support for the training programs within its premises. FCA will provide qualified and experienced faculty, study materials, and other resources required for effective coaching.

Monitoring and Evaluation:

Both PDCH and FCA will collaborate to monitor the progress of students and evaluate the effectiveness of the training programs. Regular feedback sessions will be organized to address any concerns and make necessary improvements.

Confidentiality:

Both PDCH and FCA agree to treat any confidential information shared between the parties during the collaboration, including but not limited to student data, coaching methodologies, and other proprietary information, shall be treated as confidential and not disclosed to third parties without prior written consent

Intellectual property:

Any intellectual property created during the collaboration, including marketing materials, designs, and strategies, shall be owned by Priyadarshini Dental College & Hospital

TERMINATION:

This MOU may be terminated by either party with a written notice, if there is a breach of any terms mentioned herein or if mutually agreed upon.

- a. This MOU shall remain in effect from the date of signing for a period of three years. The MOU may be extended or renewed for additional period of time upon the mutual written consent of the parties subject to such terms and conditions as the parties shall determine.
- b. If either party believes the stated purposes of this MOU are not being fulfilled, the other party shall be notified of the areas of concern in writing. Both parties shall attempt to resolve those concerns through common efforts. If no solution can be achieved, either party may terminate this MOU by providing written notification at least two months in advance; provided, such termination shall not affect the on-going program if any.
- c. If the termination is for other party's non-compliance with any material term of this MOU, the party desiring to terminate will contact the other party in writing and such party shall have thirty (30) days to correct the situation (cure period). If situation is not corrected after thirty (30) days cure period;

provided, however, that such termination shall not take effect with respect to the on-going program if any.

- d. The parties may immediately terminate this MOU in the event that there is change in law, regulations or policy of the government, which are not in conformity with the terms and conditions of this MOU.

FORCE MAJEURE

If as a result of an act of force majeure, including without elimination, an act of nature, war, riot, labor dispute, strike, threat thereof, intervention of a Government agency or instrumentality, or other occurrence beyond the reasonable control of either party, a party hindered in performing its obligations here under or is there by rendered unable to perform its obligation here under, then, in such event, such party shall have the right, upon notifying the other of the occurrence of force majeure as here in defined, to suspend performance until the event of force majeure has passes. In the event that either party is unable to perform or a period in excess of two (2) months at any time after the commencement date of this MOU due to an act of force majeure, the other party may, at its option, terminate the MOU.
