





ANTI RAGGING COMMITTEE

In relevance with the orders and instructions from DCI and UGC the Anti - ragging committee, Anti - ragging squad and monitoring cell has been formed in the Priyadarshini Dental College & Hospital. This was constituted primarily to help the students and guide them to eradicate the ragging within the campus. The further constitution, members and the details of the Anti-ragging committee and squad are hereby furnished in attachment with this order for the immediate reference of the students.

It is hereby directed that, eradicating ragging would be the duty and rights of every individual in the college. If any form of ragging instigated upon the freshers, by the senior students or hostellers of Priyadarshini Dental College & Hospital, it can be immediately resorted to the committee either by the students directly or through the squad. It is the duty of the committee to ensure that ragging in any forms in compliance with UGC guidelines if reported, to make an enquiry and bring forward any repulsive action or punishments. The punishments for the ragging would be legally directed from the reports of UGC or lawsuit in reverence with anti-ragging norms. It would also be the duty of the committee to foresee the activities of the squad in prohibiting ragging and report the same to the anti-ragging monitoring cell of Priyadarshini Dental college& Hospital, when called for.

The various faculty members, such as teaching and non-teaching, are directed to vigil strictly in the college campus and report any form of ragging witnessed by him/her, to the head of the institution and to the members of anti-ragging committee/squad. In addition periodic awareness activities / orientation programs / counselling sessions are to be conducted under the monitoring cell.




